INTERNATIONAL TRANSPORT AGREEMENT

- 1- Unless otherwise specified, the packaging, disassembly and assembly of all goods at the address where the goods are left are the responsibility of our company.
- 2- In the event that the goods become damaged or completely unusable during transport, the damaged goods are covered on the basis of the policy concluded between the owner of the goods and the insurance company.
- 3- In case the goods are incompletely delivered to the address where they are left and are lost, the entire liability shall lie with our company.
- 4- If our company does not deliver the goods on the specified date, a 10% discount on the transport costs will be granted for delay.
- 5- The parties have the right to withdraw from this contract up to 5 (five) working days before the transport date. If either party withdraws 4 (four) days before the transport date, it accepts and undertakes to pay 15% of the transport price and if it withdraws 24 hours or less before the transport date, it accepts and undertakes to pay 20% of the transport price.
- 6- If our company fails to fulfil any condition in this contract, the owner of the goods has the right to terminate this contract.
- 7- Our company will be covered by the saddle insurance of the vehicle, which will cover any natural disaster or theft damage that the goods may suffer en route during transportation.
- 8- The damage / loss of the packaging made by the owner of the goods belongs to the owner of the goods.

1- Terms of payment;

The price for the contractual transport service shall be determined by mutual agreement at at Value added tax is not included in this price.

2- The distance travelled during transport;

- a. Transport of the goods packed by our company to the warehouse with the assigned low tonnage vehicle.
- b. Transport from the warehouse to Europe with a high tonnage vehicle in accordance with international regulations.
- c. Delivery from our warehouse in Europe to the customer's address with low tonnage vehicles in accordance with the European syllabus.

3- Termination of the contract;

This contract ends when our company delivers the removal goods undamaged to the new address, places them in accordance with the contract and leaves this address. If damage to the removal goods is detected during delivery, this must be recorded in a protocol. After our company has left this address, claims for damages that have not been established with a report are invalid.
